In addition to practicing standard preventative measures such as hand washing, cleaning practices, and the use of PPE when required, Belle Vernon Area School District will continue to practice standard mitigation efforts to include reducing close contact when feasible.

a.	Handwashing and respiratory etiquette;	Teach and reinforce good hygiene measures such as hand washing, covering coughs, and face coverings.
		Provide hand soap, hand sanitizer with at least 70% alcohol, cleaning wipes/disinfectant spray, tissues, and paper towels in all classrooms and frequently trafficked areas.
		The District will communicate how to stop the spread of COVID-19 as well as inform stakeholders of symptoms, preventative measures (including staying home when sick), good hygiene, proper respiratory etiquette and school/district specific protocols.

Cleaning and maintaining healthy facilities, including improving ventilation;	Daily cleaning of schools with soap and water, disinfectants and/or sanitizers to decrease the possibility of contamination. Additional cleaning to frequently touched surfaces and objects including door and sink handles.
		Follow standard protocols to clean surfaces that are not high touch.
		Ensure ventilation systems operate properly and increase circulation of outdoor air as much as possible.
		If necessary, the use of additional cleaners and "misting agents" will also be used.

## Strategies, Policies, and Procedures

a. Contact tracing in combination with isolation and quarantine, in collaboration with the State and local health departments;

The District will follow the recommended guidelines from CDC/PADoH on the reporting of positive cases in the school district. Only as necessary or required by CDC/PADoH will the District be actively involved in contact tracing.

Students/staff who are directed by a medical professional to isolate or quarantine will remain at home and follow the direction of local health authorities and their family/primary care physician.

Students/staff who test positive for COVID19 will be excluded from school/ work for 5 days. Upon return to school/ work, it is recommended that a mask be worn during days 6-10 following a positive test for COVID 19.

The District will not exclude students who are direct contacts with positive cases unless otherwise directed by the CDC/PADoH guidelines for symptomatic/asymptomatic individuals.

a. Diagnostic and screening testing;

Students/staff who present with symptoms consistent with COVID-19 will be screened by the school nurse and be provided with recommended follow up procedures.

Share with parents a system for home/ self- screening and reporting procedures.

Encourage staff to stay home if they are sick and encourage parents to keep sick children home.
